Notes on the Contributors

Ernest Aryeetey (1955) is director of the Institute of Statistical, Social and Economic Research (ISSER) of the University of Ghana, Legon. He has been with the research faculty of ISSER since 1986. His research focuses on the economics of development with interest in role of institutions, regional integration, economic reforms, and financial systems in support of small enterprise development. He has been visiting professor at Yale University and at the Department of Economics at Swarthmore College (2001-2002). He has been a consultant to various international agencies. He is a resource person of the African Economic Research Consortium, Nairobi, and a managing editor of the *Journal of African Economies*. Among his publications are *Financial Integration and Development in Sub-Saharan Africa* (1998) and *Economic Reforms in Ghana: The Miracle and the Mirage* (2000).

Hannah Bargawi (1980) is a researcher at Debt Relief International, helping to administer the research and advocacy arm of this capacitybuilding organisation. She has co-authored various studies on issues relating to debt, new finance and the Bretton Woods Institutions. Prior to this she worked as a teaching and research assistant at the School of Oriental and African Studies where she completed a masters in development economics.

Amar Bhattacharya (1952) is senior advisor, Poverty Reduction and Economic Management Network at the World Bank. In this capacity, he is responsible for coordinating the Bank's work on international financial architecture. He was principal author of a World Bank study on *Private Capital Flows to Developing Countries* and has authored several publications relating to recent financial crisis. Since joining the Bank, he has a long-standing involvement in East Asia, including as division chief for Country Operations, Indonesia, Papua New Guinea and the South Pacific. Prior to joining the World Bank, he worked as an international economist at the First National Bank of Chicago. **Graham Bird** (1947) is professor of economics and director of Surrey Centre for International Economic Studies. He is currently working on a series of research projects dealing with various aspects of the IMF's operations, currency crises and economic recovery, and macroeconomic policy in developing countries. He has recently completed a research project examining the catalytic effect of lending by the IMF and World Bank and is co-directing a study on the political economy of the IMF. He has been a consultant to the Commonwealth Secretariat, the World Bank, WIDER, UNICEF, and UNDP. He was economic adviser to the Brandt Commission, and member of the editorial board of the Trade Policy Research Centre, and of the North-South Roundtable. He has been an adviser to the Independent Evaluation Office of the IMF and is a visiting scholar in the IMF's Research Department. He has published many books and articles. His most recent book is *The IMF and the Future: Issues and Options Facing the Fund* (2003).

Stijn Claessens (1959) is senior adviser in the Financial Sector Vice-Presidency of the World Bank. He started his career as a research fellow at the Economic Research Unit and Project LINK of the Wharton School, University of Pennsylvania, and has been a visiting assistant professor at the School of Business Administration, New York University, before joining the World Bank in 1987. From 2001 to 2004, he was professor of International Finance Policy at the University of Amsterdam. His current policy and research interests are firm finance and access to financial services; corporate governance; internationalisation of financial services; and risk management. He has provided advice to numerous emerging markets in Latin America, East Asia and transition economies. His research has been published in the Journal of Financial Economics, Journal of Finance and Quarterly Journal of Economics. He is on the Editorial Board of the World Bank Economic Review and an associate editor of the Journal of Financial Services Research, and a fellow of CEPR.

Roy Culpeper (1947) is president of the North-South Institute in Canada since 1995. He joined the North-South Institute in 1986 and was vice-president and coordinator of research from 1991 until he was appointed president. Before joining the Institute, his work experience included positions in the Manitoba government's Cabinet Planning Secretariat, the Federal Department of Finance, and the Department of External Affairs and International Trade. From 1983 to 1986, he was

advisor to the Canadian executive director at the World Bank. At the Institute, he has conducted research on a broad range of issues relating to international finance including a comprehensive study of regional development banks. He is the author of numerous publications including *Titans* or Behemoths? The Multilateral Development Banks; and Global Development Fifty Years after Bretton Woods. Since his appointment as president, the Institute has annually published the Canadian Development Report.

Louis Kasekende (1958) is deputy governor at the Bank of Uganda since November 2004. Previously he served as alternate executive director and later as executive director at the World Bank for Africa Group 1 including 22 countries mostly from anglophone sub-Saharan Africa. Prior to joining the World Bank, he served as deputy governor at the Bank of Uganda from 1999 to 2002; executive director Research and Policy at the Bank of Uganda from 1994 to 1999; director of the Research Department at the Bank of Uganda from 1992 to 1994. After completing his studies at Makerere University and the University of Manchester he tutored in both universities. Between 1991-1996 he lectured part-time in the MA Program in Economic Policy and Planning at Makerere University.

Ron Keller (1958) is director general International Cooperation at the Dutch Ministry of Foreign Affairs since 2000. He started his career in 1984 as adviser in the International Monetary Affairs Division at the Dutch Ministry of Finance where he became in 1986 personal assistant to the minister of finance who acted as chairman of the IMF Interim Committee and in 1987 senior adviser World Bank. From 1988 to 1991 he was the head of the Multilateral Banks Division. In 1991 he left the ministry to become executive director for the Netherlands at the EBRD. In 1993 he returned to the Ministry of Finance as director of the Export Credit Insurance and Investment Guarantees Directorate. From 1997 to 2000 he was director of the Foreign Financial Relations Directorate and chairman alternate of the Economic and Financial Committee of the European Union.

William Lyakurwa (1948) is executive director of the African Economic Research Consortium. He joined AERC from the International Trade Centre based in Geneva, Switzerland in 1993, where he held the post of senior trade promotion advisor. Since 1994, he held the positions of director of training and deputy executive director until his appointment to the position of executive director in March 2003.

He has been advisor and consultant to governments, regional bodies, multilateral institutions, international and non-governmental organisations. He has served as chair and member of several policymaking Boards in Tanzania and internationally. He has also served as chair and head of several national committees on trade and capacity building. He has published extensively in local and international journals as well as contributed chapters in books, research and discussion papers.

Matthew Martin (1962) is director of Debt Relief International and Development Finance International, both non-profit organisations which build developing countries' capacities to design and implement strategies for managing external and domestic debt, and external official and private development financing. Previously he worked at the Overseas Development Institute in London, the International Development Centre in Oxford, and the World Bank, and as a consultant to many donors, African governments, international organisations and NGOs. He has co-authored books and articles on debt and development financing.

Mark Plant (1955) is assistant director in the Policy Development and Review Department of the IMF, where he is primarily responsible for the development of the IMF's policies toward low-income countries. Prior to that he was chief of division responsible for reviewing all loans to low-income countries at the same department. Before that, he served nine years in the African Department of the IMF, most recently as chief of IMF missions to Ghana, Guinea, Cape Verde and Chad. Before joining the IMF, he served as deputy undersecretary and acting undersecretary for Economic Affairs in the United States Department of Commerce. Prior to that he spent two years as a senior economist at the General Motors Corporation. He began his career teaching economics at the University of California, Los Angeles and at Princeton University, where he published papers in the fields of labour economics, econometrics and macroeconomics.

Jan Joost Teunissen (1948) is director of FONDAD. He started his career in 1973 as a social scientist and freelance journalist in Chile. Seeing his plan to work in Chile's agrarian reform and rural development aborted by the coup d'état of 11 September 1973, he engaged himself in activities aimed at the return of democracy in Chile. He focused on economic boycott as a political instrument to bring about regime change in Chile and other dictatorships. In his work on interna-

tional economic and political issues, he forged links with academics, politicians, journalists and high-level policymakers in various parts of the world. In the Netherlands he stimulated discussions on the origins and solutions to the international debt crisis.
